A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY FOR THE RELEASE AND ADMINISTRATION OF AN INNOVATION FUND, AND FOR OTHER PURPOSES.

WHEREAS, Section 2 of Republic Act (RA) No. 11293, otherwise known as the Philippine Innovation Act, declares the policy of the State to foster innovation as a vital component of national development and sustainable economic growth. Section 3 (f) of the same law defines innovation as the creation of new ideas that results in the development of new or improved policies, products, processes, or services which are then spread or transferred across the market;

WHEREAS, pursuant to Republic Act No. 11936, or the General Appropriations Act of FY 2023 (GAA), the National Innovation Council was tasked to administer a One Hundred Million (P100,000,000.00) Peso-Innovation Fund, which involve a competitive selection for recipients of Innovation Grants, or non-repayable grants for innovation programs, projects, and activities;

WHEREAS, consistent with the GAA and its mandate under National Economic Development Authority – Department of Budget and Management Joint Memorandum Circular No. 2023-01, the NEDA called for applications to the Innovation Grant;

WHEREAS, the City Government of Pasig applied for and successfully secured an Innovation Grant of Four Million Six Hundred Twenty Thousand Pesos (PhP4,620,000.00) for the piloting and further scaling of "Citizen-Centric Traffic and Infrastructure Monitoring System for Long-term, Sustainable Urban Mobility and City Planning in Pasig City", an application that was developed by Balik Scientist Engr. Syrus Gomari with the City Transportation Development and Management Office and the Traffic and Parking Management Office;

NOW, THEREFORE, be it resolved by the City Council of Pasig City, in regular session duly assembled, to authorize the City Government of Pasig, through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the National Economic Development Authority for the release and administration of the Innovation Grant of Four Million Six Hundred Twenty Thousand Pesos (PhP4,620,000.00) in favor of the City Government of Pasig;
