A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A USUFRUCT AGREEMENT WITH THE PHILIPPINE NATIONAL POLICE EASTERN POLICE DISTRICT FOR THE USE OF CITY GOVERNMENT PROPERTIES AS THE PASIG CITY POLICE HEADQUARTERS AND SUBSTATIONS 2 AND 4, AND FOR OTHER PURPOSES.

WHEREAS, Section 16 of Republic Act No. 7160, or the Local Government Code of 1991, provides that every local government unit exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. It shall also maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the City Government of Pasig is the lawful owner of the following lots and its improvements located within Pasig City:

WHEREAS, the Philippine National Police ("PNP") Eastern Police District is currently occupying the aforementioned properties as the Pasig City Central Police Station (CPS) Headquarters, CPS Substation 2, and CPS Substation 4, respectively;

WHEREAS, upon agreement with the City Government of Pasig, the use and enjoyment of these properties is without any pecuniary consideration and only for the sole purpose that the PNP Eastern Police District may effectively carry out its mandate in Pasig City;

WHEREAS, the City Government of Pasig and the PNP Eastern Police District intend to enter into a usufruct agreement to further define and determine their respective rights and obligations relative to the City-owned lots and improvements;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.






