WHEREAS, in Resolution No. 171-11, series of 2023, the City Government of Pasig, through the Honorable City Mayor, was authorized to enter into and sign a Deed of Donation with the Department of Transportation (DOTr) for the donation of charging terminals, solar PV, battery storage system, and solar inverter to be used in the Low Carbon Urban Transport System Project ("LCT Project") as its pilot site;

WHEREAS, the United Nations Development Programme (UNDP) is the partner of the DOTr in the implementation of the LCT Project, and is funded under the Global Environmental Facility;

WHEREAS, there is a need to amend the said Resolution due to the following reasons:

1. UNDP has procured and owns the various equipment to be transferred to the City Government of Pasig, and as such, it is the proper party to the documents to be executed; and
 2. Per UNDP's policy, UNDP's country office here in the Philippines, which a party to the Deed, can only execute a Deed of Transfer and Acceptance when the intention is to transfer property it owns, and its head office in New York City, USA is the only entity authorized to enter into and sign a Deed of Donation.
