LOT COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 011-2023000112 REGISTERED IN THE NAME OF LAWRENCE AIKEE R. ESMELI, LOCATED IN INT. FARMER'S AVE, BARANGAY MALINAO, PASIG CITY TO BE UTILIZED FOR PUBLIC USE AS A SOCIALIZED HOUSING PROJECT.

WHEREAS, this parcel of land is covered by Transfer Certificate of Title No. 011-2023000112 of the Registry of Deeds of Pasig City containing an area of One Thousand Two Hundred square meters (1,200 sq.m.);

WHEREAS, it is necessary for the City Mayor, Honorable Victor Ma. Regis N. Sotto, to negotiate with Lawrence Aikee R. Esmeli, through Atty. Arelene Mae L. Libardo, for the acquisition of the subject parcel of land;

WHEREAS, the funds necessary in the negotiation for the acquisition of the subject property shall be taken from any available funds of the City Government of Pasig;

WHEREAS, the members of the 11th City Council find the same to be in order and necessary in the furtherance of the delivery of basic services to the constituents;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to negotiate for the purchase of One Thousand Two Hundred Square Meters (1,200Sq.M.) lot covered by Transfer Certificate of Title No. 011-2023000112 registered in the name of Lawrence Aikee R. Esmeli, through Atty. Arelene Mae L. Libardo, located in Barangay Malinao, Pasig City to be utilized as a housing project for the benefit of Malinao residents.

RESOLVED, FURTHER, that the budgetary requirement to implement this Resolution shall be chargeable to the General Fund, as certified by the City Budget Office, and subject to existing COA rules and regulation.

RESOLVED, FINALLY, that a copy of this resolution be furnished the City Mayor, and other concerned offices/agencies for their information and appropriate action.




