Gonzales, for the payment of just compensation of One Hundred (100) square meters lot which was affected by the construction of Linear Park located at Brgy. Buting, Pasig City, covered by Original Certificate of Title No. 2022000041;

WHEREAS, the portion of the above parcel of land was affected by the construction of a linear park located at Brgy. Buting, Pasig City but they have not been paid nor compensated by the City Government of Pasig up to the present time. Hence, the registered owners of the property are requesting the City Government of Pasig for the payment on the said property;
