WHEREAS, this parcel of land is covered by Transfer Certificate of Title No. 54449 containing an area of One Hundred Fifty square meters (150 sq. m.), more or less, with an improvement under Tax Declaration No. E-011-00687 ("subject property");

WHEREAS, the subject property is within the vicinity of La Immaculada Concepcion School and within close proximity to significant landmarks such as the Pasig City Hall, Pasig Public Market, and the Immaculate Conception Church;

WHEREAS, the City Government of Pasig will be undertaking the Pasig City Hall Complex Expansion and Redevelopment Project;

WHEREAS, it is necessary for the City Mayor, Honorable Victor Ma Regis N. Sotto, to negotiate with land owner of the subject property for the acquisition and utilization of the same for the Pasig City Hall Complex Expansion and Redevelopment Project;
