A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF SEVENTEEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP 17,500,000.00) TO THE ATHLETES, COACHES, AND OTHER DELEGATION MEMBERS OF THE CITY OF PASIG WHO WILL PARTICIPATE IN THE BATANG PINOY 2023 AND PHILIPPINE NATIONAL GAMES 2023 ON DECEMBER 17-22, 2023, INCLUDING THEIR RESPECTIVE PRELIMINARY EVENTS ON DECEMBER 15-16, 2023, AND FOR OTHER PURPOSES.

WHEREAS, Section 17, Article II of the 1987 Philippine Constitution (*Constitution*) provides that, the State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, Section 19 (1), Article XIV of the Constitution also provides that, the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, Batang Pinoy was created through Presidential Executive Order No. 44, Series of 1998. It is an annual national youth sports program for athletes aged 17 years old and below;

WHEREAS, Batang Pinoy is the baseline sports program of the Philippine Sports Commission (PSC) in support of the National Sports Development agenda of the national government's desire to provide an "inclusive" sporting event for young athletes. The inclusive nature of Batang Pinoy allows out-of-school youth, sectoral and marginalized sectors to participate in multiple sporting events. It answers the needs of having a comprehensive grassroots sports program centered on values formation including nationalism, self-discipline, respect, hard work, camaraderie and sportsmanship;

WHEREAS, pursuant to Executive Order No. 163, Series 1994 Philippine National Games is an annual youth sporting event for athletes aged 18 years old and above, as provided in Executive Order No. 163, Series of 1994, aiming to develop grassroots athletes;

WHEREAS, the City Government of Pasig deems it meritorious to grant financial assistance to the delegates of Pasig City who will participate in Batang Pinoy 2023 and Philippine National Games 2023, as providing support to them can significantly help in boosting their morale as its members will face challenges during the competition;

RESOLVED, FURTHER, that the budgetary requirement to this Resolution shall be chargeable against any available funds in the City Treasury subject to existing COA rules and Regulations.

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies and offices copies of this Resolution, as duly approved and adopted by the Sangguniang Panlungsod.




