A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH WALL STREET COURIER SERVICES, INC. FOR THE DEVELOPMENT OF PROGRAMS AND ACTIVITIES TO EMPOWER LOCAL E-COMMERCE ENTERPRISES WITHIN THE CITY OF PASIG, AND FOR OTHER PURPOSES.

WHEREAS, Section 3 of the Local Government Code of 1991 provides that the participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development;

WHEREAS, the Philippine electronic commerce industry has significantly expanded during the pandemic and continues to contribute to national as well as local economic targets through innovations, platforms, technology, and allied services that enhance revenues and sustain growth among its participants;

WHEREAS, this sustained growth has benefitted from the services offered by logistics, particularly, last mile delivery companies, which transport merchandise from the nearest distribution hub to the final destination, such as a home or business, and make the fulfillment of online orders more convenient for both sellers and consumers;

WHEREAS, apart from delivery service, last mile logistics companies also provide employment and other income-generation opportunities through the services offered and provided to e-commerce market players;

WHEREAS, as a business entity, last mile logistics providers face unique risks and threats in the communities or geographical areas where they operate that can potentially disrupt business operations and impede the delivery of services for e-commerce customers;

WHEREAS, open lines of communication, partnerships, and continuing commitment to shared goals between the public and private sectors are key to mitigating as well as effectively addressing these risks and threats;

WHEREAS, the City Government of Pasig recognizes both the contributions to the local economy of last mile delivery companies as well as the risks and threats they face, endeavors to establish within its territorial jurisdiction a conducive socio-political environment for the continuity of business operations of last mile delivery companies located therein;
