WHEREAS, Section 3 of Republic Act No. 7160, or the Local Government Code of 1991, provides that the participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged;

WHEREAS, Section 16 of the Local Government of 1991 empowers local government units to exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare and the health and safety of its constituents;

WHEREAS, under Section 12 (c)(13) of Republic Act No. 10121, or the Philippine Disaster Risk Reduction and Management Act of 2010, the Local Disaster Risk and Reduction Management Office shall develop, strengthen, and operationalize mechanisms for partnership or networking with the private sectors, civil society organization, and volunteer groups;

WHEREAS, the delivery of basic services is vital and must be ensured during disasters and/or emergencies, whether natural or man-made; Further, disaster risks and hazards may be reduced through disaster preparedness and mitigation by the requisite stakeholders for the protection of life and property;

WHEREAS, Arellano University operates its Andres Bonifacio Campus located in Pagasa St., Brgy. Caniogan, Pasig City;

WHEREAS, in light of the exigencies caused by calamities and/or disasters and to provide for the immediate needs of affected constituents, the City Government of Pasig intends to engage Arellano University as a partner in its disaster preparedness efforts;

WHEREAS, Arellano University has offered to the City Government of Pasig its Andres Bonifacio Campus as an evacuation site for the City of Pasig, and in return, the City Government of Pasig shall offer free disaster trainings to Arellano University to capacitate the latter's response team in times of emergencies and disasters;
