**WHEREAS**, Section 153 of Republic Act No. 7160, or the Local Government Code of 1991, provides that a local government unit may impose and collect reasonable fees and charges for services rendered;

**WHEREAS**, Executive Order No. 41, Series of 2023, was issued on September 25, 2023, and urged local government units to suspend the collection of fees that are imposed in all motor vehicles transporting goods and passing through any local public roads constructed and funded by the said local government units in line with the limitation imposed to the taxing powers of the local government units pursuant to Section 133(e) of Republic Act No. 7160;

**WHEREAS**, the said Executive Order provides that the unauthorized imposition of pass-through fees has a significant impact on transportation and logistics costs, which are often passed on to consumers, who ultimately bear the burden of paying for the increase in prices of goods and commodities;

**WHEREAS**, the City Government of Pasig acknowledges the purpose of the Executive Order, which is to mitigate the adverse effects of the ongoing inflationary fluctuations on the general public;

**WHEREAS**, the City Government of Pasig also aligns itself with the principles and objectives of the Executive Order and shares its common aspiration to contribute to the welfare of the nation and its citizens;
