A RESOLUTION ADOPTING THE PASIG CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 7, SERIES OF 2023, ENTITLED: "A RESOLUTION ENDORSING AND APPROVING THE PASIG CITY RISK REDUCTION AND MANAGEMENT PLANS, PROGRAMS, AND ACTIVITIES FOR CALENDAR YEAR 2024 AND APPROPRIATING FUNDS THEREOF OUT OF THE FIVE PERCENT (5%) DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (DRRMFIP) AS EMBODIED IN THE ANNUAL BUDGET OF PASIG CITY FOR CALENDAR YEAR 2024 AMOUNTING TO SIX HUNDRED FIFTY-FOUR MILLION THREE HUNDRED THIRTY-ONE THOUSAND THREE HUNDRED EIGHTY-SIX PESOS (PHP654,331,386.00)", AND FOR OTHER PURPOSES.

**WHEREAS**, Section 21 of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 ("law"), provides that, the Local Disaster Risk Reduction and Management Fund (LDRRMF) shall not be less than five percent (5%) of the estimated revenue from regular sources of the City to be set aside for disaster risk management activities;

**WHEREAS**, the said law also provides that, of the amount appropriated to the LDRRMF, thirty percent (30%) shall be allocated as Quick Response Fund or stand-by fund for relief and recovery program;

**WHEREAS**, unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMC within the next five (5) years. Any such amount still not fully utilized after five (5) years shall revert to the general fund and will be available for other social services to be identified by the local sanggunian;

**WHEREAS**, the Pasig City Disaster Risk Reduction and Management Council through Resolution No. 7, Series of 2023, approved the Pasig City Disaster Risk and Management Fund Investment Plan in the amount of Four Hundred Fifty-Eight Million Thirty-One Thousand Nine Hundred Seventy Pesos and Twenty Centavos (Php458,031,970.20) which constitutes seventy percent (70%) of the LDRRMF while the remaining thirty percent (30%) in the amount of One Hundred Ninety-Six Million Two Hundred Ninety-Nine Thousand Four Hundred Fifteen Pesos and Eighty Centavos (Php196,299,415.80) shall be the City's Quick Response Fund for relief and recovery programs subject to the accounting and auditing regulations, as approved by the Local Development Council;

**NOW THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to adopt Resolution No. 7, Series of
