**A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A DEED OF DONATION WITH THE PROVINCIAL GOVERNMENT OF ALBAY FOR THE RELOCATION OF FORTY-FOUR WILDLIFE SPECIES FROM THE MAYBUNGA RAINFOREST PARK TO THE ALBAY PARK & WILDLIFE, AND FOR OTHER PURPOSES.**

**WHEREAS**, the City Government of Pasig operates the Maybunga Rainforest Park, also known as the Pasig City Rainforest Park, a 6.8-hectare mixed recreational and natural park;

**WHEREAS**, the Provincial Government of Albay operates the Albay Park & Wildlife, which serves as the repository and rehabilitation facility for confiscated, donated, retrieved, turned-over or abandoned wildlife species;

**WHEREAS**, the recently closed Pasig Zoo located at the Maybunga Rainforest Park housed a variety of wild animals which require appropriate management and care, to wit:

**NOW, THEREFORE**, upon motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Deed of Donation with the Provincial Government of Albay for the relocation of forty-four wildlife species from the Maybunga Rainforest Park to the Albay Park & Wildlife.

**RESOLVED, FURTHER**, that a copy of the Deed of Donation shall form an integral part of this Resolution;

**RESOLVED, FINALLY**, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.




