A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN MEMORANDA OF AGREEMENT WITH THE JOLLIBEE FOOD GROUP AND ITS CORPORATE ENTITIES FOR THE TEMPORARY EMPLOYMENT OF QUALIFIED ELDERLY AND DIFFERENTLY-ABLED INDIVIDUALS IN THE CITY OF PASIG, AND FOR OTHER PURPOSES.

**WHEREAS**, Article XIII, Section 11 of the 1987 Philippine Constitution provides that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health and other social services available to all the people at affordable costs, prioritizing the needs of the underprivileged sick, elderly, disabled, women and children;

**WHEREAS**, the above policy of the Constitution treats the elderly and the differently-abled as similarly situated in terms of being afforded essential goods, health and other social services relevant to their needs;

**WHEREAS**, the City Government of Pasig recognizes the invaluable role of the elderly and the differently-abled in the development of the City, and aims to provide opportunities for its elderly and differently-abled constituents who have the capacity and desire to work, or be re-employed;

**WHEREAS**, the Jollibee Food Group is one of the fastest-growing restaurant companies in the world. Its corporate umbrella include Perf Restaurants, Inc., Fresh 'N Famous Foods, Inc. and Jollibee Foods Corporation, which carry the brands Burger King Philippines, Greenwich Philippines, Chowking Philippines, and Jollibee, respectively;

**WHEREAS**, the Jollibee Food Group offered to accommodate the qualified elderly and differently-abled individuals for temporary employment in its company-owned Burger King Philippines, Greenwich Philippines, Chowking Philippines, and Jollibee branches located in Pasig;

**WHEREAS**, the City Government of Pasig and Jollibee Food Group intend to formalize their partnership through the execution of Memoranda of Agreement;

**NOW, THEREFORE**, upon motion duly seconded, the Sangguniang Panlungsod ng Pasig resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign Memoranda of Agreement with the Jollibee Food Group and its corporate entities for the temporary employment of qualified elderly and differently-abled individuals in the City of Pasig.
