A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE NATIONAL TRAINING SCHOOL OF BOYS TO AUGMENT THE SOCIAL WELFARE SERVICES AND INTERVENTIONS PROVIDED BY THE KANLUNGAN SA PASIG TO CHILDREN IN CONFLICT WITH THE LAW, AND FOR OTHER PURPOSES.

WHEREAS, Republic Act No. 9344, or the Juvenile Justice and Welfare Act of 2006, as amended by Republic Act No. 10630, or the Act Strengthening the Juvenile Justice System in the Philippines, mandates local government units to adopt a Comprehensive Local Juvenile Intervention Program or Local Plan for Children to address concerns of Children in Conflict with the Law (CICL) and Children at Risk (CAR);

WHEREAS, the Juvenile Justice and Welfare Act of 2006 also institutionalized the promotion of the well-being of CICL and CAR, involvement of parents and guardians, promotion of diversion;

WHEREAS the amended law further emphasized policies focused on the best interest of these children and established an intensive Juvenile Intervention and Support Center through the Bahay Pag-Asa that provides temporary care and services as a rehabilitation center for CICL and CAR with a goal of eventually reintegrating these children with their families;

WHEREAS the City of Pasig is committed to providing accessible social services to its constituents and through the Kanlungan sa Pasig offers various programs and services for the prevention, protection, rehabilitation, reintegration, support and aftercare of CICL and CAR, and to ensure their welfare, normal growth and development;

WHEREAS, the National Training School for Boys is a residential care facility that provides intensive and comprehensive programs and services for the rehabilitation of male CICLs aged fifteen (15) and below eighteen (18) years old whose sentence has been suspended and committed by their respective courts for rehabilitation to improve self-image; attainment of normal psychological functioning; able to cope with and adjust in family and community; and can have a more productive life;

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the National Training School for Boys to augment the social welfare services and interventions provided by the Kanlungan sa Pasig to Children in Conflict with the Law.

RESOLVED, FURTHER, that a copy of the Memorandum of Agreement shall form an integral part of this Resolution.

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.


