A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00) TO THE BARANGAYS OF PASIG CITY FOR THEIR PARTICIPATION IN THE CITY'S YEAR-END ACTIVITIES, AND FOR OTHER PURPOSES.

**WHEREAS**, Section 455 of Republic Act No. 7160, otherwise known as the Local Government Code of the Philippines ("Code"), mandates the City Mayor to ensure the improvement of the quality of life of the inhabitants in each of the City's component barangays;

**WHEREAS**, Section 457 of the same Code, also mandates the Sangguniang Panlungsod to promote culture and the arts, and provide funds for their development;

**WHEREAS**, among the projects approved by the Sangguniang Panlungsod in the City's Supplemental Budget for FY 2023 are the various activities for the city's 450<sup>th</sup> Founding Anniversary – which includes the annual celebration of *Paskotitap*;

**WHEREAS**, to ensure the barangay's active participation in the said events, the City Government of Pasig deems it proper to grant, for each barangay, Fifty Thousand Pesos (Php 50,000.00) as seed money to participate in *Paskotitap*, subject to reportorial requirements to the City Accounting Office for the funds' proper liquidation;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto to grant financial assistance in the amount of Fifty Thousand Pesos per barangay (Php 50,000.00), or a total of One Million Five Hundred Thousand Pesos (Php 1,500,000.00) out of the approved budget of the City, as seed money to the Thirty (30) barangays for their participation in *Paskotitap* 2023.

**RESOLVED, FURTHER**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury subject to existing COA rules and regulations.






