A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH AMANG RODRIGUEZ MEDICAL CENTER TO SERVE AS A REFERRAL LABORATORY FOR THE PASIG CITY CHILDREN'S HOSPITAL-CHILD'S HOPE FOR COVID-19 ASSAY TESTING, AND FOR OTHER PURPOSES.

WHEREAS, 1987 Constitution mandates the right of every Filipino to health. As such, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Sections 15 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provide that local government units shall ensure the health and safety of its inhabitants. Towards this end, cities may exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of health care services, which includes access to secondary and tertiary health care services;

WHEREAS, Amang Rodriguez Medical Center is a tertiary licensed facility with a molecular laboratory that has the required facilities, equipment, and experienced and trained personnel to carry out the needed services to perform testing for COVID-19 (SARS-CoV-2) by Realtime Polymerase Chain Reaction (PCR);

WHEREAS, the City Government of Pasig operates the Pasig City Children's Hospital – Child's Hope now known as Pasig Hope Medical Center ("PCCH"), a Level 2 General Hospital, which caters to the general public;

WHEREAS, the City Government of Pasig is in need of an accredited molecular testing laboratory that can provide assay testing for COVID-19 (SARS-CoV-2) detection by polymerase chain reaction (PCR) for its client availing of the said test in PCCH, and desires to engage Amang Rodriguez Medical Center as its referral laboratory in the event of equipment breakdown in PCCH;

WHEREAS, Amang Rodriguez Medical Center has offered its services to the City Government of Pasig, through the PCCH, and the latter has accepted the said offer;

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with Amang Rodriguez Medical Center to serve as a referral laboratory for the Pasig City Children's Hospital-Child's Hope for Covid-19 Assay Testing.

RESOLVED, FURTHER, that a copy of the Memorandum of Agreement shall form an integral part of this Resolution;
