A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH RIZAL MEDICAL CENTER TO AUGMENT THE BLOOD BANK FACILITY OF THE PASIG CITY CHILDREN'S HOSPITAL-CHILD'S HOPE, AND FOR OTHER PURPOSES.

WHEREAS, 1987 Constitution mandates the right of every Filipino to health. As such, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Sections 15 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provide that local government units shall ensure the health and safety of its inhabitants. Towards this end, cities may exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of health care services, which includes access to secondary and tertiary health care services;

WHEREAS, the City Government of Pasig operates the Pasig City Children's Hospital – Child's Hope now known as Pasig Hope Medical Center, a Level 2 General Hospital with a blood bank duly licensed and authorized by the Department of Health, Philippines, to collect, process, test, and distribute quality blood products;

WHEREAS, the Rizal Medical Center, a tertiary (Level IV) teaching and training hospital under the Department of Health and within the jurisdiction of Pasig, has Blood Bank Service Facilities and is duly authorized to collect, process, test, and distribute quality blood products;

WHEREAS, the Pasig City Children's Hospital – Child's Hope requires the services of RMC as part of its operation as a Blood Service Facility in collecting, processing, testing, safekeeping, and utilizing the blood products for its clients, and Rizal Medical Center has agreed to provide the same;

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with Rizal Medical Center to augment the blood bank facility of the Pasig City Children's Hospital-Child's Hope.

RESOLVED, FURTHER, that a copy of the Memorandum of Agreement shall form an integral part of this Resolution;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.
