**WHEREAS**, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities which includes sites for police and fire stations and substations and the municipal jail;

**WHEREAS**, the Bureau of Jail Management and Penology ("BJMP"), Bureau of Fire Protection ("BFP") and Philippine National Police ("PNP"), requested for the support of the City Government of Pasig in augmenting its office supplies such as printers and inks necessary for its daily operations;
