NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor Ma Regis N. Sotto to grant financial assistance in the amount of Sixty-Six Thousand and Fifty Pesos (Php66,050.00) to defray the cost of its participation in the 4th Quarterly Ranking & National Competition of the Philippine Dancesport Federation held on October 28-29, 2023 at the Philsports Arena.

RESOLVED, FURTHER, that the budgetary requirement to implement this Resolution shall be chargeable to the General Fund subject to existing COA rules and regulations.

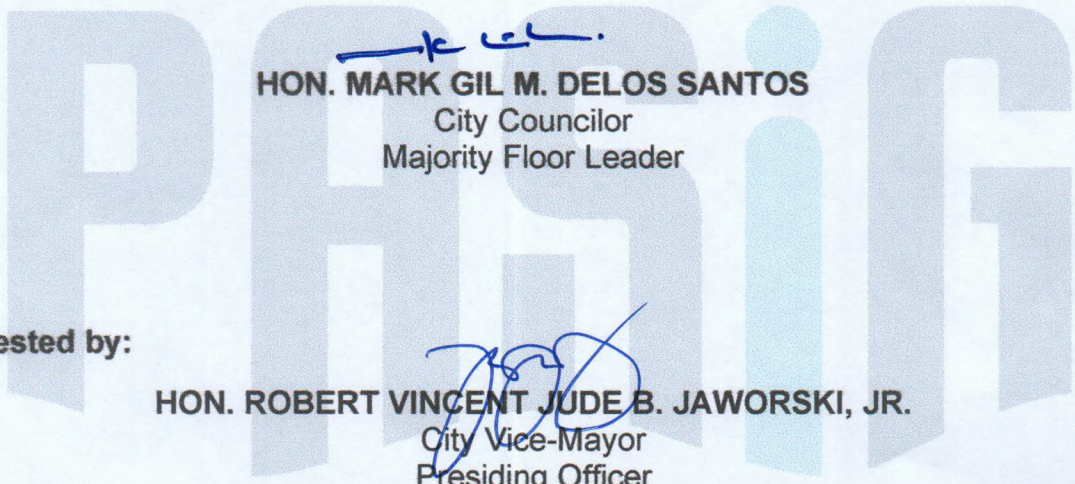
