A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT - NATIONAL CAPITAL REGION AND THE PUBLIC EMPLOYMENT SERVICE OFFICE - PASIG CITY TO ESTABLISH, OPERATE, AND MAINTAIN A JOB PLACEMENT OFFICE AT THE PAMANTASAN NG LUNGSOD NG PASIG, AND FOR OTHER PURPOSES.

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to protect labor, promote full employment, ensure equal work opportunities, and regulate the relation between workers and employers;

WHEREAS, Republic Act No. 8759 as amended by Republic Act No. 10691, otherwise known as the Public Employment Service Office Act of 1999, mandated the establishment and operation of the Public Employment Service Office (PESO), and the operation of Job Placement Offices in Educational Institutions (EIs) in all provinces, cities, and municipalities, which shall be operated and maintained by local government units. The PESO shall be linked to the regional offices of the DOLE for coordination and technical supervision, and to the DOLE central office, to constitute the national public employment service network;

WHEREAS, Section 3 of the same Act also mandates that upon the request of accredited non-government organizations (NGOs) or EIs, the DOLE may enter into a memorandum of agreement for the NGOs and EIs to establish, operate, and maintain a PESO and a job placement office, respectively;

WHEREAS, the PESO at the NGOs and the job placement office in EIs shall coordinate their activities with the appropriate LGU PESO to harmonize the provision of employment services in a given territorial jurisdiction;

WHEREAS, the DOLE-National Capital Region aims to strengthen the employment services through the implementation of various employment programs and bridging mechanism to effectively respond to job-skills gap and address the concerns of unemployment and underemployment;

WHEREAS, the DOLE-NCR intends to establish partnerships with higher educational institutions as a means of proactively seeking to expand its reach to the various stakeholders, particularly the students and new entrants to the workforce, in order to realize its mandate;

WHEREAS, the City Government of Pasig has established its own PESO by virtue of City Ordinance No. 47, Series of 1993, which is a non-charging employment facilitation and service office that serves as the implementing arm and conduit of DOLE-NCR in providing the employment needs of the residents of Pasig City;

WHEREAS, the Pamantasan ng Lungsod ng Pasig, a higher educational institution established by virtue of City Ordinance No. 11, Series of 1999, intends to forge a partnership with DOLE and PESO-Pasig City to fulfill its mission and vision by honing the potentials of its students and provide opportunities to enable them to be productive members of the society, and seeks to be an accredited Job Placement Office in Pasig City;

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the Department of Labor and Employment and the Public Employment Service Office-Pasig City to establish, operate, and maintain a Job Placement Office at the Pamantasan ng Lungsod ng Pasig.


RESOLVED, FURTHER, that a copy of the Memorandum of Agreement shall form an integral part of this Resolution;



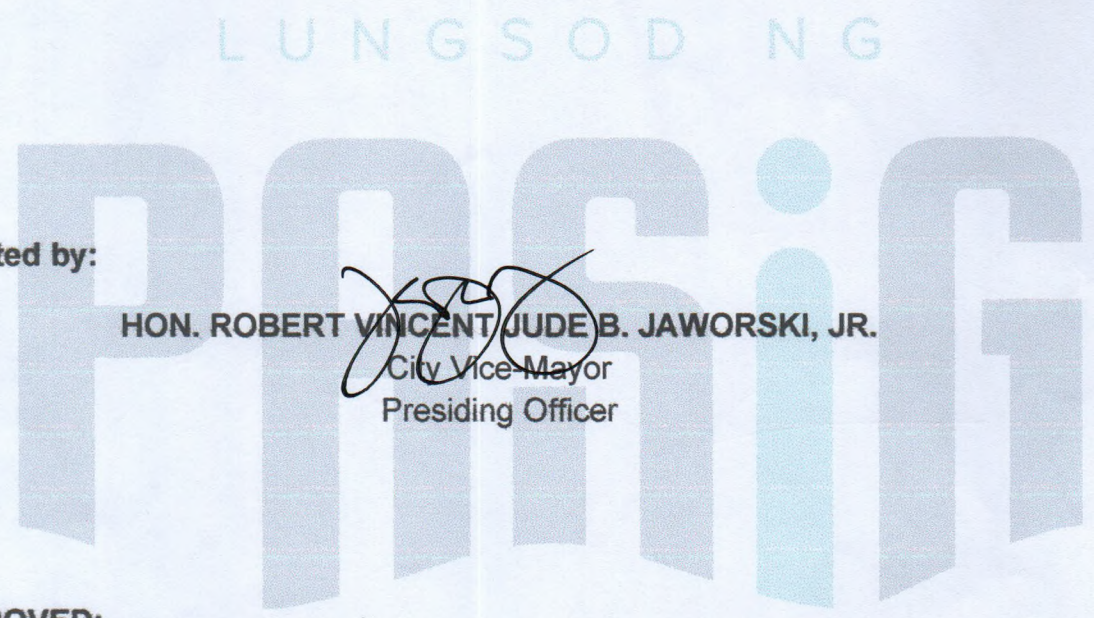
