A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE VICTOR MA REGIS N. SOTTO, TO GRANT MONTHLY FINANCIAL ASSISTANCE TO METROPOLIS II & III HOMEOWNERS ASSOCIATION IN THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00) TO SUBSIDIZE THE MONTHLY ELECTRICAL CONSUMPTION OF THE STREETLIGHTS LOCATED AT METROPOLIS VILLAGE II & III, BARANGAY STA. LUCIA, PASIG CITY, AND FOR OTHER PURPOSES.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare;

WHEREAS, the Metropolis II and III Homeowners Association sought assistance from the City Government of Pasig to subsidize the monthly electrical consumption of their streetlights within Metropolis II and III, Barangay Sta. Lucia, Pasig City;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the City Government of Pasig, through the Honorable Mayor Victor Ma. Regis N. Sotto, to grant monthly financial assistance in the amount of Ten Thousand Pesos (Php 10,000.00) to the Metropolis II and III Homeowners Association as subsidy for the payment of the public streetlights located within the Metropolis II and III Subdivision, Barangay Sta. Lucia;

RESOLVED, FURTHERMORE, that the budgetary requirement to implement the said Resolution shall be chargeable against any available funds in the City Treasurer, subject to existing rules and regulations of the Commission on Audit;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod shall furnish all concerned agencies and/or offices with copies of this Resolution, as duly, adopted and approved by the Sangguniang Panlungsod.
