**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE ANTI-DRUG ABUSE ADVOCATES OF THE PASIG CITY ANTI-DRUG ABUSE OFFICE, AND FOR OTHER PURPOSES.**

**WHEREAS**, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 provides that, every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, the Pasig City Anti-Drug Abuse Office (PCADAO) is mandated to the planning, implementation, and evaluation of drug abuse prevention activities; provide for and effective mechanism for the coordination of existing services and programs; conduct information and education campaign against illegal drugs; and monitor and report to proper authorities' drug pushers and drug users in the City;

**WHEREAS**, PCADAO is implementing its Community-Based Drug Rehabilitation Program (CBDRP) with the help of its Anti-Drug Abuse Advocates (Advocates);

**WHEREAS**, the Advocates are composed of thirty (30) volunteer individuals who provide assistance to PCADAO for the implementation of CBDRP, which encompasses group sessions, capacity building, enrichment projects, family and moral/spiritual intervention, community service, skills and livelihood training, and job placement;

**WHEREAS**, PCADAO recommended that a partnership between the City Government and its Advocates be established, and a Memorandum of Agreement be entered into to formalize the collective undertaking of the two parties against illegal drug abuse;
