WHEREAS, Republic Act No. 8792, also known as the E-Commerce Act, recognizes the use of electronic commercial and non-commercial transactions and electronic signature to facilitate and promote the universal use of electronic transactions in the government and by the general public;

WHEREAS, the City Government of Pasig intends to continue the adoption and enhancement of its Remittance Verification Monitoring System (RVMS) for the processing and collection of payment for taxes, government services, and other fees from its clients pursuant to the E-Commerce Act;

WHEREAS, the City Government of Pasig also aims to improve its transactions systems and procedures in compliance with Republic Act No. 11032, or the Ease of Doing Business and Efficient Government Services Delivery Act of 2018;

WHEREAS, Maya Philippines, Inc. ("Maya") offers Maya Payment Solutions ("PPS"), which includes products such as Maya QR, Maya One, Maya Checkout and Email Invoicing, and Maya In-App Bills Payment;

WHEREAS, the City Government of Pasig intends to avail of Maya's PPS to accommodate payments for taxes, government fees and other fees from the clients of the City, and Maya is willing to extend and provide its PPS and related services to the City Government of Pasig under the terms and conditions embodied in a Memorandum of Agreement;

WHEREAS, the Development Bank of the Philippines has been chosen as the depositary and financial settlement bank of the City Government of Pasig relative to the use of the Maya's PPS;

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with Maya Philippines, Inc. and Development Bank of the Philippines for the use of Maya Payment Solutions in the City Government of Pasig;
