WHEREAS, Ordinance No. 75, Series of 2023, entitled "An Ordinance Providing Guidelines for the Approval of Multi-Year Contracts or Projects, for the issuance by the Sangguniang Panlungsod of Multi-Year Contractual Authority" mandates that there shall be a Multi-Year Contractual Authority Resolution issued by the Sanggunian for infrastructure projects that require more than twelve (12) months to implement, complete, and accept;

WHEREAS, the Sangguniang Panlungsod has approved the budget for the construction of two (2)-6 storey 180 units and one (1)-7 storey 120 units medium-rise building housing project at Daang Banca Street, Brgy. San Andres, Cainta, Rizal ("Project") with an Approved Budget for the Contract amounting to PHP 932,500,000.00;

WHEREAS, the issuance of this Resolution is proper considering that the completion of work for the Project requires five hundred fifty (550) calendar days or more than twelve (12) months;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Government of Pasig to enter into a Multi-Year Contract for the construction of two (2) - 6 storey 180 units and one (1) - 7 storey 120 units Medium-Rise Building Housing Project at Daang Banca Street, Brgy. San Andres, Cainta, Rizal.

RESOLVED, FURTHER, that the budgetary requirements for the implementation of the Project shall be chargeable against the available funds in the City Treasury subject to existing COA rules and regulations.

RESOLVED, FINALLY, that copies of this Resolution shall be disseminated to all concerned offices.






