WHEREAS, Section 34 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of the local autonomy;

WHEREAS, Article 64 of the Implementing Rules and Regulation of the Local Government Code of 1991 provides for the procedure and guidelines for the selection of representatives of Civil Society Organizations (CSOs) in the Local Special Bodies;

WHEREAS, the Department of the Interior and Local Government (DILG), through Memorandum Circular No. 2022-083, provided a guideline for accreditation of civil society organizations and selection of representatives to the local special bodies;

WHEREAS, the City Government of Pasig conducted a Civil Society Organization Conference last August 5, 2022 for the purpose of orientation and call for accreditation of different CSOs;

WHEREAS, various CSOs have applied for accreditation and recognition to the Civil Society Organizations Desk of the City Government of Pasig, and upon processing and evaluation by the CSOs Desk, the following CSOs are favorably recommended for accreditation by the Sangguniang Panlungsod of Pasig City, to wit:
