A RESOLUTION RECOGNIZING AND CONGRATULATING ALL THE PASIG CITY ATHLETE WINNERS IN THE RECENTLY CONCLUDED PHILIPPINE NATIONAL GAMES AND BATANG PINOY 2023.

WHEREAS, Article II, Section 17 of the 1987 Constitution declares that the State shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, Article XIV, Section 19 of the 1987 Constitution states that the State shall promote physical education and encourage sports programs, league competitions and amateur sports including training for international competitions, to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry;

WHEREAS, Section 438 (a) of the Local Government Code, as amended by Republic Act No. 10742, authorized the elected Pederasyon President to serve as an ex-officio member of the Sangguniang Panlungsod and the chairperson of the Committee on Youth and Sports Development;

WHEREAS, Section 8 (h) of Republic Act No. 10742 puts forth the function of the Sangguniang Kabataan in the planning and executing projects and programs of specific advocacies including sports development;

WHEREAS, the Philippine Youth Development Plan of 2023 to 2028 by the National Youth Commission expects the youth to be represented in the adult-dominated structures wherein they would assume in the involvement in leadership roles, responsibilities and participation in youth and community-based organizations;

WHEREAS, to encourage participation of the youth of Pasig City, the inclusion of the Philippine National Games and Batang Pinoy to the Pasig City Sports Development Program in the following years is also proposed;

WHEREAS, the Sangguniang Kabataan Councils of Pasig City may collaborate for further reinforcement such as the Barangay Councils and act as an foremost champion in the promotion and advocacy of sport development through sports programs;

WHEREAS, the City Government of Pasig recognizes the success of the Pasig City delegates in the recently concluded National Championships of Philippine National Games and Batang Pinoy held from December 18-22, 2023 as

our City claimed the Overall Best Performing Local Government Unit in the Philippine National Games wherein the City clinched 42 Gold, 38 Silver, and 47 Bronze medals; and 1st runner-up – Overall Best Performing Local Government Unit in Batang Pinoy wherein the City garnered 57 Gold, 56 Silver, and 74 Bronze medals;

WHEREAS, in accordance with Section 3, Ordinance No. 52, Series of 2018, athletes, coaches and trainers qualified in the criteria enlisted in the aforementioned ordinance are entitled to cash benefits as follows:
