A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH – METRO MANILA CENTER FOR HEALTH DEVELOPMENT FOR THE IMPLEMENTATION OF THE ANNUAL OPERATION FOR THE LOCAL INVESTMENT PLAN FOR HEALTH UNDER THE UNIVERSAL HEALTH CARE ACT, AND FOR OTHER PURPOSES.

**WHEREAS**, Section 11, Article XIII of the 1987 Constitution states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all the people at affordable cost;

**WHEREAS**, Republic Act No. 7160, otherwise known as the 1991 Local Government Code, mandated the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all Local Government Units (LGUs) at all levels, further reinforced by Executive Order No. 138 on the full devolution of certain executive functions to the LGU, and the Supreme Court ruling on the *Mandanas-Garcia* petition on the share of LGUs in the National Tax Allocation;

**WHEREAS**, Section 22 of Republic Act No. 11223, otherwise known as the Universal Health Care Act of 2019 mandated the national government to make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health and health commodities, to improve the functionality of city-wide health systems, provided that the grants shall be in accordance with the approved city-wide health investment plans;

**WHEREAS**, the City Government of Pasig has agreed to implement health sector reforms consistent with the Universal Health Care Act of 2019 and has proven its capacity to utilize investments and sustain the reform process, among others;

**WHEREAS**, the Local Investment Plan for Health (LIPH) is the key instrument in forging the Department of Health (DOH) and the City Government of Pasig's partnership to carry out health reforms and is implemented through an Annual Operation Plan (AOP);

**WHEREAS**, the City Government of Pasig has agreed to fund and implement the programs, projects and activities under the respective LIPs/AOPs through its own financing sources, and through available funds and resources from the DOH, through the DOH-Metro Manila Center for Health Development, as coordinated with the DOH;
