A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF HEALTH – METRO MANILA CENTER FOR HEALTH DEVELOPMENT AND THE PHILIPPINE HEALTH INSURANCE CORPORATION FOR THE LOCAL HEALTH SYSTEM INTEGRATION UNDER THE UNIVERSAL HEALTH CARE ACT, AND FOR OTHER PURPOSES.

**WHEREAS**, Section 11, Article XIII of the 1987 Constitution states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all the people at affordable cost;

**WHEREAS**, Section 16 of Republic Act No. 7610 provides that local government units (LGUs) shall ensure and support, among other things, the health and safety of its constituents;

**WHEREAS**, Sections 19 and 20 of Republic Act No. 11223, otherwise known as the Universal Health Care Act, empowers local government units to integrate the health systems into city-wide health systems, and to pool and manage, through a special health fund, all resources intended for health services to finance population-based and individual-based health services, health system operating costs, capital investments, and remuneration of additional health workers and incentives for all health workers to ensure the effective and efficient delivery of population-based and individual-based health services;

**WHEREAS**, the same Act gives a six-year transition period to LGUs that commit to city-wide integration from the enactment of the Universal Health Care Act and its Implementing Rules and Regulations, wherein managerial and technical integration is expected to be demonstrated in the first three years (2020 - 2022), and financial integration to be exhibited within the next three years (2023 - 2025) thereafter, subject to further review after the lapse of six (6) years;

**WHEREAS**, the Department of Health is mandated to provide for technical and financial support, as appropriate and in consideration of the available budget, to LGUs that commit to city-wide integration;

**WHEREAS**, the strategic financing initiatives of the Philippine Health Insurance Corporation (PhilHealth) shall support the functions of LGUs in providing quality health care at all levels of the health system pursuant to the directives of the Universal Health Care Act;






