WHEREAS, Republic Act No. 11310 or "An Act Institutionalizing the Pantawid Pamilyang Pilipino Program," otherwise known as the "4Ps Act," defines 4Ps as the national poverty reduction strategy and a human capital investment program that provides conditional cash transfer to poor households for a maximum of seven years, to improve the health, education, and nutrition aspect of their lives;

WHEREAS, Joint Memorandum Circular No. 2022-001 issued by the Department of Social Welfare and Development (DSWD) and Department of the Interior and Local Government (DILG) underscores the role of local government units (LGU) in providing support for both active and exiting households belonging to the Pantawid Pamilyang Pilipino Program (4Ps), through various social protection and poverty reduction programs, consistent with the full devolution mandated by Executive Order No. 38;

WHEREAS, the Pasig City Social Welfare and Development Office (CSWDO) provides numerous essential social services and community programs to provide protection, aid, and support from the government to the country's most vulnerable sectors, including providing support for graduating and exiting 4Ps households;

WHEREAS, the Pasig City Health Department (CHD) offers a wide range of health-related programs and initiatives throughout the city;

WHEREAS, the Pasig City Local Economic Development and Investment Office (LEDIO) has the mandate of encouraging, developing, and supporting local businesses and entrepreneurs, and planning for sustainable livelihood opportunities for Pasigueños;

WHEREAS, Palladium International, LLC, is an international consulting firm engaged by the United States Agency for International Development (USAID) to implement the USAID- funded CATALYZE program in the Philippines (CATALYZE PH), which aims to promote social protection, health and wellbeing, and economic empowerment of current and former 4Ps beneficiaries, specifically through the joint efforts of the CSWDO, CHD, LEDIO, and PESO in the provision of health, relationship, and life skills mentorship support to youth and adolescent female 4Ps in Pasig City;

NOW, THEREFORE, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Understanding with Palladium International, LLC for the implementation in Pasig City of the CATALYZE Program funded by the United States Agency for International Development.


