A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT FOR THE IMPLEMENTATION OF THE POPULATION CENSUS AND COMMUNITY-BASED MONITORING SYSTEM IN THE CITY OF PASIG IN 2024.

WHEREAS, Republic Act (RA) No. 11315 also known as the CBMS Act, institutionalized the Community-Based Monitoring System (CBMS), an organized technology-based system of collecting, processing, and validating necessary disaggregated data that may be used for planning, program implementation, and impact monitoring at the local level while empowering communities to participate in the process;

WHEREAS, R.A. No. 11315 mandates the Philippine Statistics Authority (PSA) to be the lead agency in the implementation of the CBMS, while Rule VI, Section 7 of the Implementing Rules and Regulations of the CBMS Act mandates the Department of the Interior and Local Government (DILG) to develop and implement information and education campaign relating to CBMS, ensure compliance of local government units (LGUs) in the various CBMS activities, and extend assistance to the PSA in the conduct and implementation of the CBMS;

WHEREAS, Section 4 of the CBMS Act provides that the LGU is the primary data collecting authority within its locality;

WHEREAS, the PSA NCR II Office intends to have the mid-decade Population Census coincide with the 2024 CBMS rollout;

WHEREAS, the LGU is mandated to collaborate with the PSA and DILG to implement the CBMS in their locality;

NOW, THEREFORE, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the Philippine Statistics Authority and the Department of the Interior and Local Government for the implementation of the second round of Population Census and the Community-Based Monitoring System in Pasig City.

RESOLVED, FURTHER, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.




