A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF TWO HUNDRED FIFTY-FIVE THOUSAND PESOS (PHP 255,000.00) TO THE THIRTY (30) SANGGUNIANG KABATAAN TREASURERS OF PASIG CITY FOR THEIR MANDATORY BOOKKEEPING TRAINING ON JANUARY 29 TO FEBRUARY 2, 2024, AND FOR OTHER PURPOSES.

WHEREAS, Section 2 of Republic Act No. 10742, also known as the SK Reform Act of 2015 (Act), as amended, provides that, the State recognizes the vital role of the youth in nation-building and thus, promotes and protects their physical, moral, spiritual, intellectual, and social well-being, inculcates in them patriotism, nationalism, and other desirable values, and encourages their involvement in public and civic affairs;

WHEREAS, the same Act provides that the Sangguniang Kabataan Chairperson shall appoint a treasurer with an educational or career background relating to business administration, accountancy, finance, economics, or bookkeeping. Provided that, only if no person meets the requirements can the SK chairperson consider other suitable nominees;

WHEREAS, the Implementing Rules and Regulations of the said Act provides that appointed Sangguniang Kabataan Treasurers shall undergo mandatory bookkeeping training from, and must be duly certified by the Technical Education and Skills Development Authority (TESDA) before the assumption of office. Provided that, the mandatory bookkeeping training shall be in addition to the mandatory training under Section 31 of the said Rules. Provided further, that only the certification from TESDA shall be considered for purposes of appointment as SK treasurer;

WHEREAS, the City Government of Pasig deems it meritorious to hereby grant financial assistance to the thirty (30) Sangguniang Kabataan Treasurers of Pasig City to help defray the cost of their Bookkeeping training at ACCESS Pasig, Barangay San Nicolas, Pasig City;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto to grant financial assistance in the amount of Two Hundred Fifty-Five Thousand Pesos (Php255,000.00) to the thirty (30) Sangguniang Kabataan Treasurers of Pasig City to help defray the cost of their mandatory Bookkeeping Training on January 29 to February 2, 2024.

RESOLVED, FURTHER, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.






