A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO SIGN A DEED OF DONATION WITH THE PHILIPPINE POSTAL CORPORATION FOR THE DONATION OF AN OFFICE EQUIPMENT, AND FOR OTHER PURPOSES.

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, the Philippine Postal Corporation (PHILPOST) is mandated to plan, develop, promote and operate a nationwide postal system with a network that extends or make available, at least ordinary mail service, to any settlement in the country, including Pasig City;

WHEREAS, in order for PHILPOST to continuously provide quality services to the constituents of Pasig City, the administration of the PHILPOST requested for the support of the City Government of Pasig in augmenting its office equipment necessary for its daily operations;

WHEREAS, the City Government of Pasig is the owner of one (1) unit of Kyocera Ecosys M4125IDN photocopier and it intends to donate the same to the PHILPOST in support of and in recognition of its invaluable service to the City of Pasig, and the PHILPOST is willing to receive the above-described office equipment;

NOW, THEREFORE, upon motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Deed of Donation with the Philippine Postal Corporation for the donation of an office equipment.

RESOLVED, FURTHER, that a copy of the Deed of Donation shall form an integral part of this Resolution;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.
