Sotto to grant financial assistance to the Pasig Chapter of the Regional Trial Court-Clerks of Court Association of the Philippines in the amount of One Hundred Twenty Thousand Pesos (Php120,000.00), to help defray the cost of its participation in the National Convention of the Regional Trial Court-Clerks of Court Association of the Philippines to be held on March 14 to 15, 2024 in the City of Manila.

**RESOLVED, FURTHERMORE**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.
