**WHEREAS**, the Sangguniang Panlungsod has received, for adoption and legislative action, a copy of the Supplemental Investment Program (SIP) No. 1 for Fiscal Year (FY) 2024 in the amount of Six Billion Five Hundred Nineteen Million One Hundred Ninety-Nine Thousand One Hundred Thirty and 37/100 Pesos (Php 6,519,199,130.37) as approved by the City Development Council (CDC) by virtue of CDC Resolution No. 2024-001;

**WHEREAS**, the Supplemental Investment Program No. 1 was borne from the discussions of the CDC that certain programs, projects, and activities could no longer be implemented for the year, and that funding for the same may be used for equally urgent programs, projects, or activities aimed at helping the city attain its development goals and objectives;

**WHEREAS**, after deliberating on the Supplemental Investment Program No. 1 for FY 2024 submitted by the Pasig CDC, the Sangguniang Panlungsod found it to be in order and in accordance with the City's development thrusts;

**WHEREAS**, the adoption of the Supplemental Investment Program No. 1 is crucial as it serves as the basis for the funding of programs, projects, and activities of the city for the 2024 Supplemental Budget No. 1;

**NOW, THEREFORE**, upon motion duly seconded by all members present, the Sangguniang Panglungsod, resolves, as it is hereby resolved, to adopt the Supplemental Investment Program No. 1 of the City Government of Pasig for Fiscal Year 2024 in the amount of Six Billion Five Hundred Nineteen Million One Hundred Ninety-Nine Thousand One Hundred Thirty and 37/100 Pesos (Php 6,519,199,130.37), covering various expenditures for the operation of the City Government and for additional developmental programs, projects, and activities.
