A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO TO GRANT FINANCIAL ASSISTANCE TO THE PASIG CITY SWIMMING TEAM IN THE AMOUNT OF FORTY-NINE THOUSAND FIVE HUNDRED PESOS (PHP49,500.00) FOR ITS PARTICIPATION IN THE CONGRESS OF PHILIPPINE AQUATICS INC. NATIONAL CAPITAL REGION ONE FOR ALL - ALL FOR ONE SWIM SERIES LEG 1 ON FEBRUARY 11, 2024 AT THE CITY OF MANILA.

**WHEREAS**, Section 17, Article II of the 1987 Constitution states that, the State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

**WHEREAS**, the Congress of Philippine Aquatics Inc. will hold its COPA NCR One for All - All for One Swim Series Leg 1, a competition with individual and relay events, at the Rizal Memorial Sports Complex, Manila on February 11, 2024;

**WHEREAS**, the Pasig City Swimming Team intends to send 65 participants composed of male and female grassroots athletes from both public and private schools in Pasig City, and has requested financial assistance from the City Government to enable them to participate in the said swim competition;

**WHEREAS**, the City Government of Pasig recognizes that continuous support is necessary to further strengthen the City's grassroots program, which the Sangguniang Panlungsod finds in order;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto to grant financial assistance to the Pasig City Swimming Team in the amount of Forty-Nine Thousand Five Hundred Pesos (Php49,500.00) for its participation in the Congress of Philippine Aquatics Inc. National Capital Region One For All - All For One Swim Series Leg 1 on February 11, 2024 at the City of Manila.

**RESOLVED, FURTHER**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations;

**RESOLVED, FINALLY**, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.

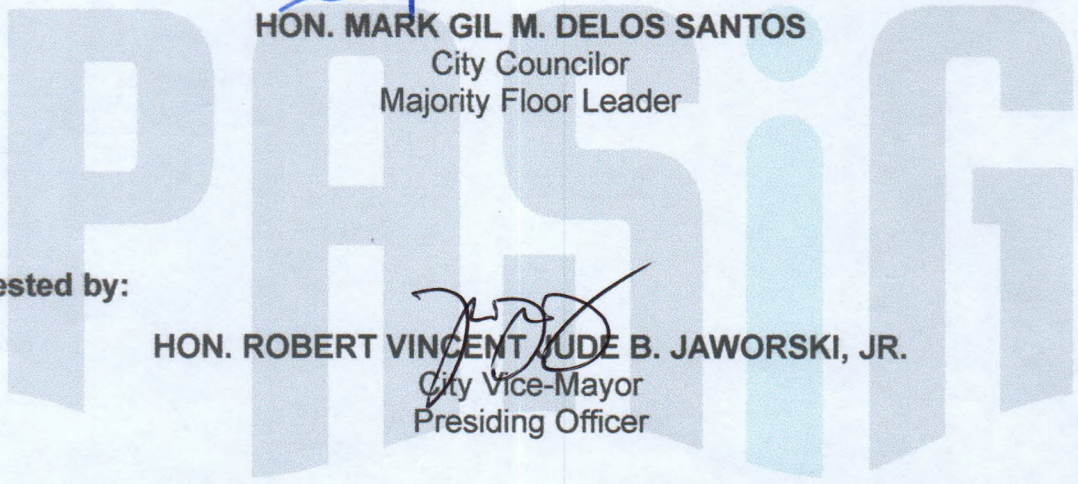
