SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH RONALD MCDONALD HOUSE CHARITIES OF THE PHILIPPINES, INC. FOR THE CONSTRUCTION OF A RONALD MCDONALD BAHAY BULILIT CHILD DEVELOPMENT CENTER IN BARANGAY MANGGAHAN, PASIG CITY, AND FOR OTHER PURPOSES.

**WHEREAS**, Section 17 of Republic Act No. 7610 provides that local government units shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of social welfare services which include programs and projects on child and youth welfare, family and community welfare;

**WHEREAS**, the Ronald McDonald House Charities Philippines, Inc. ("RMHC") is a non-profit organization registered with the Department of Social Welfare and Development ("DSWD") as an Auxiliary Social Welfare and Development Agency, particularly as a Resource Agency, that provides financial support and capability – building programs to various partners primarily for the benefit of disadvantaged children 4 years old and below as well as grade 1 students in the National Capital Region, among others;

**WHEREAS**, the Ronald McDonald Bahay Bulilit is a flagship program of RMHC in partnership with local government units and the DSWD aimed at providing children a safe space to play and learn, while their parents – who might not be able to afford private childcare or private centers – are at work;

**WHEREAS**, the City Government of Pasig, through its City Social Welfare and Development Office, continues to forge partnerships with private organizations to ensure that its child development programs and interventions remain responsive to the needs of the local communities;

**WHEREAS**, upon consultation with the City Government of Pasig and Barangay Manggahan, the RMHC has pre-qualified and selected a site in Barangay Manggahan, Pasig City where a Ronald McDonald Bahay Bulilit Child Development Center shall be constructed. The said child development center is expected to cater to a maximum of thirty (30) children per session;
