A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FIRE PROTECTION, AND FOR OTHER PURPOSES.

**WHEREAS**, Section 13 of Republic Act No. 9514, also known as the Fire Code of the Philippines 2008, provide that, "All taxes, fees and fines provided in this Code shall be collected by the BFP: Provided, that twenty percent (20%) of all such collections shall be set aside and retained for use by the city or municipal government concerned, which shall appropriate the same exclusively for the use of the operation and maintenance of its local fire station, including the construction and repair of fire station: Provided, further, that the remaining eighty (80%) shall be remitted to the National Treasury under a trust fund assigned for the modernization of the BFP.";

**WHEREAS**, the Department of Finance, Department of Budget and Management and Department of Interior and Local Government issued Joint Circular No. 2015-01 which provide the guidelines in releasing the twenty percent (20%) share of the Local Government Unit in the Fire Code Revenues collected by the Bureau of Fire Protection;

**WHEREAS**, a Memorandum of Agreement between the Bureau of Fire Protection and City Government of Pasig is necessary for the release of the twenty percent (20%) share of the local government share in the Fire Code fees collection;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod of Pasig resolved, as it hereby resolved, to authorize the City Government of Pasig, through the honorable City Mayor, Victor Ma. Regis N. Sotto to enter into and sign a Memorandum of Agreement with the Bureau of Fire Protection for the release of twenty percent (20%) Local Government share in the Fire Code collection.

**RESOLVED, FINALLY**, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.
