A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF PASIG AND THE UNIVERSITY OF ASIA AND THE PACIFIC TO ESTABLISH AN INTERNSHIP PROGRAM IN THE CITY OF PASIG, AND FOR OTHER PURPOSES.

WHEREAS, Section 13, Article 1 of the 1987 Constitution declares it a policy of the State to recognize the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, the City Government of Pasig, through the Cultural Affairs and Tourism Office, operates the Pasig City Museum, a two-storey house which bears art pieces, artifacts, and memorabilia of the history of Pasig and its people;

WHEREAS, the University of Asia and the Pacific, an institution of higher education, desires to engage the City Government of Pasig to adequately expose its undergraduate (320 required internship hours) and graduate (160 required internship hours) students under the Humanities Program to actual work situations, and to enable them to acquire the necessary knowledge, skills, attitudes, and values required in the working world;

WHEREAS, the City Government of Pasig is offering opportunities to students who are interested in familiarizing themselves with government processes, providing administrative support to the programs, plans, and activities of the Pasig City Museum and the Cultural Affairs and Tourism Office, and other activities that align with the overall developmental thrust of the City Government under an internship program;

WHEREAS, the University of Asia and the Pacific intends to send qualified undergraduate and graduate humanities students to participate in the said internship program, and the City Government of Pasig accepts these students under the terms and conditions embodied in a Memorandum of Agreement;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the University of Asia and the Pacific for the conduct of an internship program in the City of Pasig.
