WHEREAS, the Karate Pilipinas Sports Federation, Inc. ("KPSKI") is the only karate federation recognized by the World Karate Federation, Asian Karate Federation and the Philippine Olympic Committee. The KPSKI shall hold its 5th Karate Pilipinas National Championship 2024 on March 1 to 3, 2024 at the Tagaytay Combat Sports Center, Tagaytay City, Cavite;

WHEREAS, the tournament shall consist of the following events: Coach and Referee Licensing Examination; Cadet, Juniors, Under 21 and Seniors Championship and Selection; and 6-13 years old Category Kata and Kumite;

WHEREAS, the Pasig City Karatedo Team is asking for financial support from the City Government of Pasig for its participation in the said tournament;

WHEREAS, providing support to the team can significantly help in boosting the performance and morale of its members who will face challenges during the competition knowing that the City Government is behind them;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto to grant financial assistance to the Pasig City Karatedo Team in the amount of One Hundred Sixty-Six Thousand Pesos (Php166,000.00) to help defray the cost of its participation in the 5th Karate Pilipinas National Championship 2024 to be held on March 1-3, 2024 at the Tagaytay Combat Sports Center, Tagaytay City, Cavite.
