**WHEREAS**, Ordinance No. 75, Series of 2023, entitled "An Ordinance providing guidelines for the approval of Multi-Year Contracts or Projects, for the issuance by the Sangguniang Panlungsod of Multi-Year Contractual Authority" mandates that there shall be a Multi-Year Contractual Authority Resolution issued by the Sanggunian for infrastructure projects that require more than twelve (12) months to implement, complete, and accept;

**WHEREAS**, the Sangguniang Panlungsod has approved the budget for the procurement of Design and Build Services (demolition of existing structures within Pasig City Hall compound and construction of the new Pasig City Hall, Caruncho Avenue, Brgy. San Nicolas, Pasig City) ("Project") with an Approved Budget for the Contract amounting to Nine Billion Six Hundred Forty-Four Million Nine Hundred Eighteen Thousand Pesos (PHP 9,644,918,000.00);

**WHEREAS**, the issuance of this Resolution is proper considering that the completion of work for the Project requires seven hundred twenty (720) calendar days or more than twelve (12) months;

**NOW, THEREFORE, ON MOTION DULY SECONDED, THE SANGGUNIANG PANLUNGSOD RESOLVES, AS IT HEREBY RESOLVED**, to authorize the City Government of Pasig to enter into a multi-year contract for the procurement of Design and Build Services (Demolition of existing structures within Pasig City Hall compound and construction of the new Pasig City Hall, Caruncho Avenue, Brgy. San Nicolas, Pasig City.

**RESOLVED, FURTHER**, that the budgetary requirements for the implementation of the Project shall be chargeable against the available funds in the City Treasury subject to existing Commission on Audit rules and regulations and other pertinent issuances;
