**WHEREAS**, the St. Paul College Pasig PEP Varsity Team is the cheerleading team of St. Paul College Pasig and was the champion at the National Cheerdance Competition held last March 2023;

**WHEREAS**, Cheer Pilipinas, the Philippines' governing body of cheerleading, invited the St. Paul College Pasig PEP Varsity Team to represent the Philippines in the All-Girls Elite Division of the ICU World Championship;

**WHEREAS**, the St. Paul College Pasig PEP Varsity Team is asking for financial support from the City Government of Pasig for its participation in the said competition;

**WHEREAS**, providing support to the team can significantly help boost the performance and morale of its members who will face challenges during the competition knowing that the City Government is behind them;
