A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE VICTOR MA REGIS N. SOTTO, TO GRANT FINANCIAL ASSISTANCE TO SOUTHIES CHEER CLUB IN THE AMOUNT OF FIFTY THOUSAND PESOS (PHP 50,000.00) TO HELP DEFRAY THE COST OF ITS PARTICIPATION IN THE INTERNATIONAL CHEER UNION WORLD CHAMPIONSHIP ON APRIL 28-29, 2024 AT ORLANDO, FLORIDA, USA, AND FOR OTHER PURPOSES.

WHEREAS, Section 13, Article II of the 1987 Constitution states that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, the International Cheer Union ("ICU") is the world governing body for the sport of cheer duly recognized by the International Olympic Committee. The ICU annually holds its World Championship, also known as the World Cup, dubbed as the "Olympics of Cheerleading," with around 100 hundred countries competing yearly;

WHEREAS, the Southies Cheer Club is a cheerleading group based in Metro Manila, with forty (40) members comprised of cheerleaders, coaches, and managers, that had previously competed in the ICU World Cup held in Seoul, South Korea last October 06-08, 2023. In the competition, they were named the World Cup Champions in the Senior Co-Ed Elite Division;

WHEREAS, Cheer Pilipinas, the Philippines' governing body of cheerleading, invited the Southies Cheer Club to compete in the 2024 ICU World Championship, where they aspire to achieve the title of the ICU Cheerleading Cup Champions;

WHEREAS, Seth Christopher Santos, the Communications Officer and Coach of the Southies Cheer Club, and Ronniel Madrideo, member of the Southies Cheer Club, have been residents of Pasig City for over thirty (30) years. Santos and Madrideo are also former members and volunteer coaches of the Rizal High School Phoenix Pep Squad from 2007-2018;

WHEREAS, the Southies Cheer Club is asking for financial support from the City Government of Pasig for its participation in the said competition;

WHEREAS, providing support to the team can significantly help boost the performance and morale of its members who will face challenges during the competition knowing that the City Government is behind them;




