WHEREAS, the True Colors Transport Association, Inc. has applied for the approval of their terminal site to the city government;

WHEREAS, Article 11 Section 51 of Ordinance No. 25 known as the traffic code of Pasig states that Off-street parking facilities and public transport terminals may be constructed, operated and maintained by the City or by private entities, subject to an authorization by the Sangguniang Panlungsod upon the recommendation of the Traffic and Parking Management Office (TPMO) and approval of the Mayor;

WHEREAS, as per Resolution No. 252, Series of 2005, Article 11 states:

"Article 11 - Upon the recommendation (worthiness) from the TPMO, it shall be forwarded to the Chairman, Committee on Transportation for final evaluation and to be recommended to the Sangguniang Panlungsod for approval.

Upon approval, the Business Permit and License Office (BPLO) shall issue a permit with corresponding license and fees."

NOW, THEREFORE, on motion duly seconded, the City Council resolves, as it is hereby resolved, to approve the application for terminal site of True Colors Transport Association, Inc., located at 77 F. Manalo St. Sto. Tomas, Pasig City.
