WHEREAS, Section 15, Article XIV of the 1987 Constitution states that arts and letters shall enjoy the patronage of the State. The State shall conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations;

WHEREAS, the Pasig Art Club, Inc. was established in 1957 and is one of the oldest and most recognized groups that promotes local arts and culture in the country. In celebration of National Arts and Women's Month, the PAC shall hold its Mutya ng Pasig Fashion Show and Art Exhibit on March 22 to April 11, 2024 at the Estancia Mall, Capital Commons, Pasig City, Metro Manila;

WHEREAS, the fashion show and art exhibit shall consist of the following events: a fashion show featuring the Mutya ng Pasig 2023 contestants and clothes made by local fashion designers, an artwork exhibit, a period costumes exhibit, live sketching sessions with the Mutya ng Pasig 2023 contestants, seminars on health, well-being, and women's empowerment, poetry reading, and art workshops;

WHEREAS, the Pasig Art Club, Inc. is asking for financial support from the City Government of Pasig in preparation for the said event;

WHEREAS, providing support to Pasig Art Club, Inc can help promote local culture and arts, particularly the significance of the Mutya ng Pasig, celebrate homegrown fashion designers, and other artists by providing them an avenue to showcase their talents;

NOW, THEREFORE, THE SANGGUNIANG PANLUNGSOD, RESOLVES, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor, Victor Ma Regis N.
