**WHEREAS**, the Department of Transportation intends to enter into a Right-of-Way Usage Agreement between the Local Government of Pasig City;

**WHEREAS**, the Subject Properties intended to be used is covered by Transfer Certificate of Title No. 488419 and registered under the name of the City Government of Pasig;

**WHEREAS**, through this agreement, the Local Government of Pasig City will grant the Department of Transportation and its Project Implementation Partners the free use of the Subject Properties including Lot 1 and Lot 5-H under Transfer Certificate of Title No. 488419, the Registered Owner of which is the Pasig City Government for the Construction of the Shaw Boulevard Station and construction yard.

**WHEREAS**, it is necessary for the City Mayor, Honorable Victor Ma. Regis N. Sotto, to sign with the Department of Transportation, through their authorized representative, for the Right-of-Way Usage Agreement over the Subject Properties;

**WHEREAS**, the members of the 11<sup>th</sup> City Council find the same to be in order and necessary in the furtherance of the delivery of basic services to the constituents.

**NOW, THEREFORE**, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to enter into a Memorandum of Agreement between the Department of Transportation pertaining to the ongoing Right-of-Way and Site Acquisition of the Metro Manila Subway Project, to grant the usage of the subject properties owned by the City of Pasig;
