



EXECUTIVE ORDER NO. PCG-008 SERIES OF 2022

AN EXECUTIVE ORDER PLACING THE CITY OF PASIG UNDER ALERT LEVEL SYSTEM 1 FROM 01 MARCH 2022 TO 15 MARCH 2022

WHEREAS, the Coronavirus Disease 2019 (COVID-19), since having been declared as a Public Health Emergency of International Concern (PHEIC), has irreversibly affected millions of lives and families worldwide. Its unprecedented speed of transmission and infectivity has placed a huge burden on essential area of governance, most importantly in vulnerable sectors such as the economy, education, and healthcare;

WHEREAS, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among its constituents;

WHEREAS, Section 2 (b) of Executive Order No. 168 (s.2014) mandates the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (**IATF**) to prevent and/or minimize the entry of suspected or confirmed patients with emerging infectious diseases into the country;

WHEREAS, on September 10, 2021, the President issued Proclamation No. 1218 (s. 2021) further extending the period of the State of Calamity throughout the Philippines until September 12, 2022, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases passed Resolution No. 163-A, Series of 2022 dated 27 February 2022, which deescalated the alert level classification of the National Capital Region (NCR) to Alert Level 1 effective 01 March 2022 until 15 March 2022;

WHEREAS, the IATF issued the revised guidelines on the Alert Level System by issuing the Guidelines on the Nationwide Implementation of Alert Level System for COVID-19 Response as of 27 February 2022;

NOW, THEREFORE, I, VICTOR MA. REGIS N. SOTTO, Mayor of Pasig City, by virtue of the power vested in me by law, do hereby order:

SECTION 1. ADOPTION OF IATF RESOLUTION NO. 163-A (S. 2022). – The City Government of Pasig adopts the guidelines on the implementation of Alert Level System 1 in the National Capital Region from 01 March 2022 until 15 March 2022.

SECTION 2. OPERATION OF BUSINESS ESTABLISHMENTS. – All private offices and workplaces, including public and private construction sites, may operate at full 100% capacity (consistent with national issuances on vaccination requirements for on-site work). However, they





may continue to provide flexible and alternative work arrangements as deemed appropriate based on function or individual risk.

SECTION 3. OPERATION OF LOCAL GOVERNMENT OFFICES. – All Departments, Offices, and Units of the City Government shall adhere to 100% on-site workforce. Off-site work shall be under such work arrangements subject to relevant rules and regulations issued by the Civil Service Commission and the Office of the President.

SECTION 4. GUIDELINES FOR PUBLIC TRANSPORTATION. – Public transportation shall be at full seating capacity. For intrazonal and interzonal travels involving public land transportation between an area with a higher alert level classification and an area under Alert Level 1, the passenger capacity shall be that which has the lower passenger capacity rate between the point of origin and point of destination.

SECTION 5. WEARING OF FACE MASKS. – At all times, well-fitted masks shall be worn properly, whether outdoors or in indoor private or public establishments, including in public transportation by land, air, or sea, except for the following instances:

- a. Eating and drinking;
- Participating in team and individual sports in venues where ventilation standards can be maintained;
- c. Practicing outdoor sports/exercise activities where physical distance can be maintained.

SECTION 6. PROOF OF VACCINATION. – According to the Guidelines on the Nationwide Implementation of Alert Level System for COVID-19 Response as of 27 February 2022, individuals eighteen (18) years old and above will be required to present proof of full vaccination before:

- a. Participation in mass gatherings, such as but not limited to:
 - In-person religious gatherings; gatherings for necrological services, wakes, inurnment, and funerals for those who died of causes other than COVID-19 and for the cremains of the COVID-19 deceased;
 - 2. Entry into indoor establishments, such as but not limited to:
 - In-person religious gatherings; gatherings for necrological services, wakes, inurnment, and funerals for those who died of causes other than COVID-19 and for the cremains of the COVID-19 deceased;





- All indoor dine-in services of food preparation establishments such as kiosks, commissaries, restaurants, and eateries. For outdoor or al fresco dining and take out channels, no proof of full vaccination is required;
- All indoor personal care establishments such as barbershops, hair spas, hair salons, and nail spas, and those offering aesthetic/cosmetic services or procedures, make-up services, salons, spas, reflexology, and other similar procedures including home service options;
- 6. Fitness studios, gyms, and venues for exercise and sports;
- 7. All indoor cinemas or movie houses operating at full capacity;
- Meetings, incentives, conferences, exhibition events, and permitted venues for social events such as parties, wedding receptions, engagement parties, wedding anniversaries, debut and birthday parties, family reunions, and bridal or baby showers;
- Venues with live voice or wind-instrument performers and audiences such as in karaoke bars, clubs, concert halls, and theaters;
- Indoor ancillary establishments in hotels and other accommodation establishments; and
- 11. Venues for election-related events.

Proof of full vaccination shall be required before entry in the list of establishments identified under the principles of 3C's (Closed, Crowded, and Close Contact) strategy against COVID-19.

Children ages seventeen (17) and below shall not be required to present proof of full vaccination status.

SECTION 7. CONTINUED EFFECTIVITY OF LOCAL GOVERNMENT POLICIES. – All COVID-19 related issuances, executive orders, and policies of the City Government of Pasig, insofar as they are not in contradiction to the mandates this EO or of the national government, such as the Pasig Pass Ordinance.

The force and effectivity of the same will be without prejudice to any further changes in the mandates of the local or national government.





SECTION 8. DISSEMINATION. – Copies of this Executive Order shall be furnished within seventy-two (72) hours from its issuance to the Office of the President and the Department of Health for their information and guidance.

SECTION 10. EFFECTIVITY CLAUSE. – This Executive Order shall take effect immediately upon its approval and shall remain in effect for the entirety of Alert Level Systems 1.
