



EXECUTIVE ORDER NO. PCG-22 SERIES OF 2022

AN EXECUTIVE ORDER RECONSTITUTING AND EXPANDING THE PASIG CITY HEALTH BOARD

WHEREAS, the 1987 Philippine Constitution provides that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all the people at an affordable cost;

WHEREAS, the City Government of Pasig, in accordance with this administration's commitment to transparency and accountability in local governance, underscored by genuine people's participation, serves as the blueprint for the development and reform of its local health systems;

WHEREAS, pursuant to Section 102 of the Local Government Code of 1991, there shall be a Local Health Board in every province, city, or municipality.

NOW, THEREFORE, I, VICTOR MA. REGIS N. SOTTO, Mayor of Pasig City, by virtue of the powers vested in me by law, do hereby order:

Section 1. Reconstitution of the Board. – The Pasig City Health Board is hereby reconstituted and shall be composed of the following:

Section 2. Duties and Functions. – The Pasig City Local Health Board shall perform the following functions pursuant to the Local Government Code of 1991 and its Implementing Rules and Regulations (IRR):

- a) Propose to the Sangguniang Panlungsod, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality, city, or province, as the case may be;
- Serve as an advisory committee to the Sangguniang Panlungsod, concerned on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes;
- c) Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar functions; and
- d) Such other functions that the City Mayor may direct.

Section 3. Meetings and Quorum. – The board shall meet at least once a month or as may be necessary. A majority of the members of the board shall constitute a quorum, but the chairman or the vice-chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

Section 4. Secretariat. – The Pasig City Health Department is hereby designated as Secretariat of the Pasig City Health Board. It shall provide administrative support in the conduct of meetings, take charge of communications and notices, and take custody of all records, data information, and other documents of the Board. It shall likewise prepare monthly, quarterly, and annual report of operations and activities of the Board.

Section 5. Honorarium. – The members of the Pasig City Local Health Board who are non-employees of the City Government of Pasig shall be entitled to receive an honorarium in the amount of Three Thousand Pesos (PHP 3,000.00), on the basis of actual and personal attendance in the Pasig City Health Board meetings and activities.

Section 6. Separability Clause. – The provisions of this Order are considered separable. If for any reasons, any provision or provisions, or parts thereof, be declared invalid or unconstitutional by





proper authority or tribunal, the other provisions or parts not declared thereby shall remain valid and enforceable.

Section 7. Repealing Clause. – Any order or issuance, or parts thereof, that are inconsistent with the provisions of this order are hereby repealed or modified accordingly.

Section 8. Dissemination. – A copy of this Executive Order shall be furnished to the Office of the President and Metropolitan Manila Development Authority (MMDA) for information and guidance pursuant to Section 455(1)(xii) of the RA 7160 otherwise known as the Local Government Code, as amended, and shall be posted at the official website of the Pasig City Government.

Section 9. Effectivity. - This Order shall take effect immediately.
