



**EXECUTIVE ORDER NO. PCG-33  
SERIES OF 2022**

**AN EXECUTIVE ORDER RECONSTITUTING THE PASIG ADMINISTRATIVE BOARD  
FOR NUISANCE**

**WHEREAS**, Article 2, Section 4 of the 1987 Constitution states that the primary duty of the state is to serve and protect its people;

**WHEREAS**, Section 52 of Republic Act 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, states that any city may, by ordinance, create an administrative board to hear complaints regarding drug-related and other nuisances in relation to the provisions of the New Civil Code of the Philippines;

**WHEREAS**, pursuant to the above mandates, Pasig City Ordinance No. 32, series of 2009, Ordinance No. 17, series of 2016, and Ordinance No. 08, series of 2017, were duly-enacted;

**WHEREAS**, there is a need to reconstitute such administrative board to receive complaints for purposes of declaring a place or premise a public nuisance;

**NOW THEREOF, I, VICTOR MA. REGIS N. SOTTO**, Mayor of Pasig City, by Virtue of the powers vested in me by law, do hereby order:

**Section 1. CONSTITUTION OF THE PASIG ADMINISTRATIVE BOARD FOR NUISANCE.** – The Pasig Administrative Board for Nuisance shall be comprised of the following members:

who shall sit for one (1) year from his or  
her appointment; and

One (1) Representative of a Non-  
Government Organization (NGO), who is  
a member of the Anti-Drug Abuse Council  
(ADCOP), who shall sit for one (1) year  
from his or her appointment

**Section 2. DUTIES AND FUNCTIONS OF THE PASIG ADMINISTRATIVE BOARD FOR  
NUISANCE.** – The duties and functions of the board shall be as follows:

1. To receive complaints for the purpose of declaring a place or premise a public nuisance which may be filed by any employee, officer, resident, or constituent of Pasig City;
2. To invite or summon any person to appear and testify before the board; and
3. After due notice and hearing, to declare a place or premise or any act or activity a public nuisance, by vote of majority of all its members

**Section 3. SEPARABILITY CLAUSE.** – Any provision of this Order found to be unconstitutional shall not affect the other provisions which shall remain to be in full force and effect.

**Section 4. REPEALING CLAUSE.** – Any provision of this Order found to be inconsistent herewith are hereby repealed and modified accordingly.

**Section 5. EFFECTIVITY CLAUSE.** – This Order shall take effect immediately.
