



## EXECUTIVE ORDER NO. PCG-21/2 SERIES OF 2022

## RECONSTITUTING THE PASIG CITY PEACE AND ORDER COUNCIL, DEFINING ITS FUNCTIONS, AND FOR OTHER PURPOSES

WHEREAS, Section 116 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that there shall be a City Peace and Order Council;

**WHEREAS**, Memorandum Circular No. 2011-24 dated February 17, 2011 issued by the Secretary of Interior and Local Government enumerates the duties and functions of the Peace and Order Council;

WHEREAS, pursuant to Executive Order No. 773, Series of 2009 issued by the Office of the President, the Peace and Order Council was re-organized;

NOW, THEREFORE, I, VICTOR MA. REGIS N. SOTTO, Mayor of the City of Pasig, by virtue of the power vested in me by law, do hereby reconstitute the Local Peace and Order Council of Pasig City, as follows:

**SECTION 1. Composition.** – The Pasig City Peace and Order Council shall be composed of the following members or their authorized representatives:

**SECTION 2. Duties and Functions.** – The Pasig City Peace and Order Council shall perform the following duties and functions:

- a. Formulate the City Peace and Order and Public Safety (POPS) Plan, which shall be incorporated in the Comprehensive Development Plan;
- Provide for a forum for multi-sectoral dialogue and deliberation of major issues and problems affecting peace and order, including insurgency;
- Recommend measures aimed at improving or enhancing peace and order and public safety, including anti-insurgency measures;
- d. Recommend measures to converge and orchestrate internal security operation efforts of civil authorities and agencies, military and police;
- Recommend measures to complement the national plans and programs on peace and order;
- Monitor the provision of livelihood and infrastructure development programs and projects in remote rural and indigenous population areas to isolate them from the communist rebels' ideological, political and organization works;
- g. Develop and monitor anti-illegal gambling activities, such as:
  - Development of a quick response mechanism (e.g. hotline, online services etc.)
     where the public can report illegal gambling or jueteng-related activities and
     concerns, for resolution by the city;
  - ii. Close coordination between the LGUs and the Anti-Money Laundering Council (AMLC) in the investigation and prosecution of jueteng-related money laundering cases and the establishment of an AML Desk in the city; and
  - iii. Conceptualization of alternative activities, among others.
- h. Take decisive action in emergency situations, through the creation of a Special Action Committee composed of city officers or counterparts, if any, of the Department of the Interior and Local Government, Department of National Defense, Department of Social





Welfare and Development, Department of Justice and the Armed Forces of the Philippines;

i. Perform such other functions as may be assigned by law or by the City Mayor.

**SECTION 3. Meetings and Quorum.** – The Council shall meet at least once every quarter or as often as may be deemed necessary by the Chairperson. A majority of the members of the Council shall constitute a quorum, but the Chairperson or the Vice-Chairperson must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of the majority of all the members present shall be necessary to approve proposals.

**SECTION 4. Honoraria.** – The Chairperson and City officials shall perform their duties without compensation or remuneration. Representatives from the private sector, civil society organizations, and national government agencies shall be entitled to honoraria on the basis of actual and personal attendance at meetings, subject to existing standard auditing rules and procedures of the City.

**SECTION 5. Special Action Committee.** – There shall be a Special Action Committee, the composition of which, shall be determined by the City Mayor. The Special Action Committee shall act on matters that require immediate attention and decision. All actions and decisions made by the Special Action Committee shall be within the policies laid down by the National Peace and Order Council and Pasig Peace and Order Council.

**SECTION 6. Secretariat.** – The Secretariat shall be headed by the most senior DILG Officer stationed in the City of Pasig, with three (3) personnel who will serve as the Council's Research Analyst, Information Technology Staff, and Administrative Staff. The Secretariat shall likewise be assisted by the regular staff of the City Planning and Development Office.

**SECTION 7. Functions of the Secretariat.** – The Secretariat shall perform the following functions:

- Assist in the preparation of peace and order plans and projects of the city, and monitor their implementation through incorporation in the Annual Investment Program and Budget of the City;
- b. Implement and monitor the City Peace and Order Council operations;
- c. Provide a forum for inter-agency dialogue on problems and issues affecting peace and order at the city level;
- d. Assist in the conduct of research projects and evaluation of activities; and
- e. Perform other related tasks.

**SECTION 8. Budget.** – The funding of Pasig Peace and Order Council may be charged to the Confidential/Intelligence Funds of the Office of the Mayor or to any available fund in the City Treasury, subject to the relevant guidelines on the use of the such Confidential/Intelligence Funds.





**SECTION 9. Repealing Clause.** – All other orders, issuances, memoranda, rules or regulations or parts thereof inconsistent with this Order are hereby repealed, amended, or modified accordingly.

**SECTION 10. Dissemination.** – Copies of this Executive Order shall be furnished within seventy-two (72) hours from its issuance to the Office of the President and the Metro Manila Development Authority for information and guidance, pursuant o Section 455(1)(xii) of the Local Government Code, as amended.

**SECTION 11. Effectivity.** – This Order shall take effect immediately.
