



EXECUTIVE ORDER NO. PCG-<u>52</u> SERIES OF 2022

AN EXECUTIVE ORDER MANDATING THE WEARING OF FACEMASKS FOR CLIENT-FACING PERSONNEL OF THE CITY GOVERNMENT OF PASIG

WHEREAS, Section 15, Article II of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the Local Chief Executive to institute measures towards the protection and promotion of the general welfare of the people;

WHEREAS, the World Health Organization (WHO) has recognized the continuous wearing of facemasks as a key measure to reduce transmission of diseases and to save lives;

WHEREAS, in order to protect the health of the clients, staff, and officials of the City Government of Pasig, there is a need to ensure that proper safety mechanisms are implemented, such as the continued wearing of facemasks for client-facing personnel of the City Government of Pasig.

NOW THEREFORE, I, VICTOR MA. REGIS N. SOTTO, Mayor of Pasig City, by virtue of the powers vested in me by law, do hereby order:

Section 1. MANDATORY WEARING OF FACEMASKS FOR CLIENT-FACING PERSONNEL OF THE CITY GOVERNMENT OF PASIG. – The proper wearing of facemasks, as well as the observance of the minimum public health standards such as, but not limited to, proper sanitation and observance of physical distancing, shall be mandated for all client-facing personnel of the City Government of Pasig.

Section 2. CLIENT-FACING PERSONNEL. – Client-facing personnel, for purposes of this Order, are those employees and personnel who, by the very nature of their work, interact or attend to clients, patrons, and guests on a day-to-day basis. These include, but are not limited to, receiving window staff, cashiers, and public order and security personnel.

Client-facing personnel shall also include employees and personnel who do not regularly interact or attend to clients, patrons, and guests but who will interact with clients, patrons, and guests of the City Government for any particular reason.





Section 3. COVERAGE. – This Executive Order shall be applicable to all employees or personnel of the City Government of Pasig, as well as employees and personnel working in offices located in structures owned by the City Government of Pasig.

Section 4. REPEALING CLAUSE. – Any provision of this Order found to be inconsistent herewith are hereby repealed and modified accordingly.

Section 5. EFFECTIVITY CLAUSE. – This Order shall take effect immediately.
